Columbia Chapter Rewards Program

The Columbia Chapter is starting a new program as of January 1, 2006 to both provide opportunities to earn points and a Reward in the form of reimbursement for Chapter workshops, NIGP workshops, etc., as well as to encourage Chapter members to participate in a variety of Chapter activities.

Funding for the Rewards Program will come from a portion of the revenue collected from Chapter fundraisers. Participation in a wide variety of activities will enable Chapter members to earn points throughout the year. The Chapter member(s) with the highest number of points will earn a Reward. The number of Rewards presented annually will be determined by the Columbia Chapter Board and will depend on the amount of revenue earned by fundraisers. The amount of each Reward will be \$275.00

The Rewards Program policy, including an activity points schedule will be

posted on the Columbia Chapter website in late January. Activity points can be earned by attending Chapter or NIGP workshops, representing your agency at the Reverse Trade Show, attendance at Chapter meetings, working on or chairing a committee, submitting or publishing an article in the Chapter Newsletter, being a Chapter member or national member, becoming certified or by receiving the Buyer or Manager of the year award.

It will be the responsibility of each Chapter member to maintain records regarding points earned and to submit the necessary information along with an Application for Rewards Form by January 31, 2007 to the past president.

Introduction to Public Procurement

General Description

The work of public procurement is no longer a clerical function performed independently by various people throughout different agencies or departments within a government entity. This class provides an overview of the ever-changing profession by identifying fundamental concepts that will affect procurement in the public sector.

Intended Audience

This course is intended for individuals interested in an overview of procurement functions for the purpose of understanding the basic elements that underlie all areas of public procurement. Any government employee who has delegated authority to purchase good and services on behalf of the government should take advantage of this class. Discussion and content is relevant for those outside the profession, who are impacted by the public procurement environment.

Prerequisites

There are no prerequisites for this class. Successful participants will either be new to the profession or have less than one year of experience and anyone employed in various positions within the government.
