# Legislative and NIGP National Updates

- NIGP has a new a new strategic partnership with Norwich University online both Bachelors and Masters level. You can obtain college credits for NIGP classes and for your CPPB and CPPO. Brian wanted to speak about 5 new legislative bill and two new ones that might affect our vendors.
- 2. House Bill 3264 Directs Dept. of Transportation to conduct pilot program on prompt payment of certain contracts, House Bill 3060 Prohibits state contracting agency from entering into public contract with prospective contractor that has not certified that prospective contractor has policy and practice of preventing sexual harassment, sexual assault and discrimination against members of protected classes of workers, House Bill 2899 Provides that ports may enter into intergovernmental agreements for any purpose permitted under ORS chapter 190. House Bill 2162 Requires state contracting agency that awards public improvement contract with contract price of more than \$5 million to require contractor to employ apprentices to perform 10 percent of work hours on public improvement that workers in apprenticeable occupations perform, House Bill 3203 Requires contracting agency to perform analysis to determine whether constructing public improvement with contracting agency's own equipment and personnel will result in least cost to contracting agency, House Bill 2005 Provides definitions relating to comparable work for purposes of pay equity provisions, House Bill 3458 Directs employer in specified industries to pay greater of daily or weekly overtime when employee is eligible for both in same workweek. Brian is term limited out as chapter ambassador and if anyone is interested in becoming the chapter ambassador talk to Brian in the next couple of months because that's when they begin looking for someone. Once Brian's term is up we won't have a representative from Oregon.

 Everyone who attended Forum was given a minute to say what they liked about Forum this year and all thought it was a very good experience attending this year's Forum. They thought the classes were presented well and enjoyed the interactions with the other attendees.
