### **COMMON GROUND**

#### **Objectives**

Participants have the opportunity to share about themselves and find out what they have in common with others in the room.

#### Time

10-15 minutes

#### Set Up

Put only enough chairs for each participant in a circle. You, the facilitator, will stand in the middle without a chair. This way, there is always exactly one less chair than there are people.

#### Instructions

- 1) You are going to make a statement that is true for you by saying, "I'm looking for common ground with someone who..."
- 2) Everyone who has that in common with you must stand up and find a different chair to sit in.
- 3) The person left without a chair is the next person to say, "I'm looking for common ground with someone who..."
- 4) Encourage people to look for cultural common ground. For example, someone who was raised Catholic, someone who grew up poor, someone who bows to their elders, etc.

  Depending on the relationships in the group, people may take greater risks with what they share.

#### **Debrief (optional)**

- 1) What did you notice about yourself and others in this activity?
- 2) Did anything surprise you?
- 3) What level of risk were you willing to take? Why?
